I am aware that during any trip in which I am participating under the arrangement of HRR, and its agents and associates, certain substantial risks and dangers may occur, including, but not limited to injury or death resulting from the hazards of traveling in rough trail conditions, hiking through rough terrain, accidents or illnesses in remote places without medical facilities, the forces of nature, and travel by automobile, 4x4 vehicle, ATV, motorcycle, or other conveyance.

In consideration of and as part of payment for the right to participate in such trips or other activities and the services and food, if any, arranged for me by HRR, its agents and associates, and with full knowledge of the aforementioned dangers, and intending to be legally bound, I hereby agree for myself and on behalf of all of my family and heirs to RELEASE the HRR and any of its representatives, agents, directors, officers, members, ride coordinators, and fellow riders from any and all liability, claims, demands, or any causes of action, and NOT TO SUE OR OTHERWISE MAKE ANY CLAIM against the HRR or any of its representatives, agents, directors, officers, members, ride coordinators, or fellow riders whatsoever which may arise during my participation in any activities of the HRR.

I also agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from all claims, judgments, expenses, and costs, including, but not limited to attorney's fees, incurred in connection with any claims brought as a result of my participation in HRR activities and which are released by the terms of this agreement.
